Clarificatory Note: Prior to Amendment notification to SEBI (Listing Obligations and Disclosure Requirements) Regulations ("SEBI LODR") dated March 27, 2025, the Company was categorized as a High-Value Debt Listed Entity (HVDLE). Accordingly, Regulations 15 to 27 of the SEBI LODR were applicable to the Company on a "comply or explain" basis until March 31, 2025. SEBI vide its Notification dated March 27, 2025 amended the definition of HVDLE and introduced Chapter VA, prescribing Corporate Governance norms for HVDLE (entities with an outstanding principal amount

of ₹1,000 crore or more as on March 31, 2025), effective from April 1, 2025. As on March 31, 2025, the principal outstanding of the Company's listed debt securities is less than ₹1,000 Crore. Hence, with effect from April 1, 2025, the Company is no longer HVDLE and consequently the Corporate Governance Norms prescribed under Chapter VA are not applicable to the Company from Q1FY26 onwards.
